 - 2. The Board waived the pre-employment medical exam and background check
 - 3. Position offered to Rhonda Kuehn as a part time employee.
 - a. Hourly pay rate will be at California minimum wage.
 - b. The part time position does not offer medical insurance, overtime, sick or vacation pay.
 - 4. Employment start date will be August 5, 2020.
 - 5. The Board explained that all trash acceptable will be household trash only and that no lifting is required.
 - 6. Rhonda Kuehn accepted the offer of the position and all District rules related to employment.

6. BOARD DISCUSSION/DIRECTIVES:

- The Secretary was directed to complete all required actions for new employee.
- Director Knight reported that he needed to order three new water pumps for emergency services to replace three older pumps that are no longer serviceable or repairable.
- Secretary directed to reimburse Director Knight through the checking account.

Director Knight reported that the District Fire engine is still out of commission.
